Pre-Assessment Services

Service provided	Description of service	Fee	Notes/Comments
Community Coalition Building Meeting	We host this meeting with formal and informal community leaders who might be interested in championing Communities for Youth work or joining a community coalition. The community coalition supports the Communities for Youth process throughout each step, and can be as formal or informal as needed within the local context. The community coalition is dynamic, and can evolve and grow over time as needed.	\$2000 for up to two community coalition meetings per district.	Dates and location are based on school and district requests.
Upstream Prevention Training	This is a training designed for school and community leaders where we teach the basic principles of upstream prevention, our general process, and how it can be an effective tool for improving youth well-being in the community.	\$2000 for virtual training per school, \$3000 for in-person training per school.	Dates and location are based on school and district requests.
Upstream Prevention Informational Meeting	This is a meeting we host for parents and community members to build an understanding about upstream prevention efforts and the role that data collection and assessments play in supporting youth well-being. The goal of this meeting is to educate the community and to garner support for data collection and upstream prevention efforts.	\$2000 for virtual meeting per school, \$3000 for in-person meeting per school.	Dates and location are based on school and district requests.
Community Listening Session	This session is facilitated by us. In this session, we meet with community members at-large to gather information on their views on youth well-being and ways the community is equipped to address potential risk and protective factors. This information allows school leaders to use the whole community perspective when considering the assessment results, determining actionable goals, and deciding on the best efforts to take for upstream prevention.	\$3500 for in-person meeting per school.	Dates and location are based on school and district requests.

Service provided	Description of service	Fee	Notes/Comments
School Leaders Data Summary Report Meeting	This meeting is a live review of your data summary report with our data experts. As part of this service, we provide a detailed breakdown and interpretation of the data, including an in-depth discussion of summary results, predictive model results, and assistance in the selection of key data points of interest and key risk and protective factors.	\$1000 per school for virtual meeting, \$2000 per school for in person meeting.	Dates and location are based on school and district requests.
Faculty and Staff Data Walk	This is a meeting hosted by us and designed for teachers and staff who work directly with your students, as well as other leaders at your school. This meeting focuses on a faculty and staff-oriented “data walk” in which we review key data points from the data summary report and investigate relationships between risk and protective factors and youth well-being. As part of this, we provide data visualizations (see below for more information on these).	\$4000 per meeting per school.	Dates and location are based on school and district requests.
Student Data Walk	This is a meeting hosted by us and designed for students at your school. This meeting focuses on a student-oriented “data walk” in which we review key data points from the data summary report and investigate relationships between risk and protective factors and youth well-being. As part of this, we provide data visualizations (see below for more information on these).	\$4000 per meeting per school.	Dates and location are based on school and district requests.
Whole Community Data Walk	We host this meeting, open to the community at-large, to communicate the key data points from the data summary report and gather feedback on the findings. As part of this, we provide data visualizations (see below for more information on these). This meeting is useful for gathering the community perspective on the key data points and risk and protective factors, and for creating 1-2 actionable goals based on community expectations and involvement.	\$5000 per meeting per school.	Dates and location are based on school and district requests.
Community Action Team Meetings	We host these meetings with the goal of building a collaborative strategic action plan for the community to activate on the selected goals. These meetings are open to the public.	\$3500 per meeting per school. We suggest at least three meetings a year.	Dates and location are based on school and district requests.

Service provided	Description of service	Fee	Notes/Comments
Student Focus Groups	These are structured focus groups conducted by our team with a relatively small group of students to gather more in-depth details on a few key data points. Student focus groups allow for a deeper understanding of the student perspective than the assessment can provide alone, and are useful for gathering more information on key risk and protective factors.	\$5000 per school.	Dates and location are based on school and district requests.
Adult Focus Groups	These are structured focus groups conducted by our team with a relatively small group of adults (teachers, staff, parents, and/or other community members) to gather more in-depth details on a few key data points. Adult focus groups allow for a deeper understanding of the perspective of adults in the lives of students, and are useful for gathering more information on key risk and protective factors.	\$5000 per school.	Dates and location are based on school and district requests.
Follow-Up Data Analysis	A more customized and in-depth data analysis for schools who want more information than the summary provided.	\$5000 per school.	
Data Visualizations for School/Community Use	Our data experts make up to six graphics, provided as presentation slides and/or printed on posters, on key data points. These can be used at the discretion of school leaders for school or community use.	\$1000 per school.	
Community Tip Sheets	Our research team creates an evidence-based tip sheet focused on one of the community's key risk and protective factors. This tip sheet is useful for sharing with schools, students, parents, and the community at-large to help address an issue and provide actionable and effective information on a chosen risk or protective factor. This is provided as a PDF.	\$500 per tip sheet factor.	



Technical Assistance

Service provided	Description of service	Fee	Notes/Comments
As Needed Technical Assistance	This service includes on-call technical support with our team for questions on upstream prevention efforts. This is useful for school leaders who need minimal on-hands support from us.	\$450 per month per school, up to five hours per month.	Dates and location are virtual, based on district and school requests. Schools who need more than five hours per month should contact us directly.
Full Service Upstream Prevention Package	<p>This service is designed for districts that want to become a <u>Communities for Youth initiative</u>.</p> <p>This service includes all services listed above to empower communities to initiate and sustain actionable upstream prevention strategies for youth well-being.</p>	\$110,000 per district per year.
